07-22-97 at 1309 I was contacted by Heather Thomas, who works at Kneaded Relief Massage Parlour reference to a disturbance which was occurring in front of the business.

I dispatched assist units to the 1200 block of Jefferson and started that direction while speaking with Thomas. She said that her ex-boyfriend, Yohan Pant, had just kicked a big dent in her car and was walking north on Jefferson towards Business 70.

I approached from the east. I noticed Yohan Pant walking on the south side of Business 70 near the Long John Silvers. I stopped and arrested him.

A computer check shows an outstanding warrant for misdemeanor assault. The warrant number is 054764M, the bond \$1000.00. The conditions of bond are that he have no contact with Heather Thomas.

Pant was arrested for the Boone County warrant and then brought back to the Kneaded Relief Massage Parlour on Jefferson.

I spoke with Heather Thomas. She said that she was having an argument with Yohan about the fact that he is hanging around drug dealers in Columbia. She said that he's not from Columbia and needs to go back to Florida because she is afraid that he is "hanging around with some people that he doesn't know anything about." She said that they started having an argument about him going back to Florida. He got out of the car and kicked a large dent in her right door.

I noticed Thomas' vehicle a 1984 purple RX7. There was a large dent in the right door.

I spoke with Barry Manthe. He is the owner of Kneaded Relief. He said that he was watching from the business as Yohan kicked her car, causing a large dent.

Yohan Pant admitted that he kicked the dent in the car. He told me that while they were arguing, Heather Thomas threw an ashtray at him striking him in the hand. He said there was no bruises.
