On 01-30-98 at approx. 0130 hrs, I was dispatched to Break Time on the corner of Garth and Bus. Loop reference an assault that occurred at 1203 N. Garth.

Upon arrival at the Break Time, I made contact with a Velesa L. Meloni. I observed Meloni bleeding from her bottom lip as well as blood all over her hands. Meloni was then treated by the paramedics and transported to the UMC Hospital & Clinics.

While at the hospital, Meloni stated that a female by the name of Sasha started to get into a fight with someone else at 1203 N. Garth when Meloni interfered and Sasha then started to beat up on Meloni. Meloni stated that Sasha smashed her head into the wall and onto the furniture as well as kicked her. Meloni stated that Sasha was very intoxicated.

Meloni further stated to myself and the paramedics that she had been doing Crack. I observed Meloni to have been hit in her left eye as well as cut to her lower lip. Meloni then continued to complain of her ribs hurting as she stated she had been kicked there.

Meloni stated that she tried to fight back and that is how she broke off all of her artificial fingernails.

I then went to 1203 N. Garth and made contact with a Barry Manthe. Manthe stated he was aware that Meloni had been in a fight with a Heather Thomas. Manthe stated that he had been asleep in his bedroom when he heard a commotion in the living room. He came in and saw Meloni and Thomas fighting and he then tried to break up the fight and told Meloni to leave so that Thomas would no longer hit her.

I then went back to UMC Hospital & Clinics and spoke with Meloni to ask her if she thought the person who assaulted her was Heather Thomas. Meloni stated that Heather Thomas was, in fact, the individual who assaulted her. I then gave Meloni my business card with this case number.
