On 05/28/98 I was assigned by SGT. PIESTER to process 1203 GARTH AV. NORTH, the location of a search warrant service. This location is known as the BLUE ROSE massage parlor. See associated cases 98-5112 and 98-5119. This is the second time in the last two months that a search warrant has been served at this location. Also on this date three arrest were made. In reference to these arrest see reports by service personnel. I did observe upon review that suspects SAPP and LONG were also at this same location on 04/24/98.

On 05/28/98 a systematic search was conducted of this location from 2110 to 2210 hrs. The following items of evidence were documented during this time frame.

Ex.1- Yellow wrapper with green leafy substance. Located in chair with LONG. LONG admitted that it was marijuana and it was hers. S.W. bedroom.

Ex.2- Two pipe cleaners w/residue. S.W. bedroom on and under bed were LONG occupied at time of entry.

Ex.3- One pipe cleaner rod with residue. S.W. bedroom in purse of LONG.

Ex.4- Glass pipe with possible cocaine residue. S.W. bedroom closet hidden in shoe. Room occupied by LONG.

Ex.5- MO.DR.LIC. (ALTERED) of JEFFERY MOSLEY. Recovered from MOSLEY.

Ex.6- Delinquent Notice addressed to CRYSTAL MARSHALL at 1203 N.GARTH. Located in kitchen drawer.

Ex.7- Boone County Court Notice addressed to BARRY MANTHE at 1203 N. GARTH. Located in kitchen drawer.

Ex.8- Two rolls of exposed film taken for documentation of location and evidence recovered.
