On 5/29/98 I responded with Sgt. Brian Piester of the Narcotics Unit to the address of 1207 N. Rangeline. Sgt. Piester advised me that he had probable cause to arrest a Barry Manthe for operating two businesses within the city limits of Columbia without a valid business license.

Officer Piester and I did arrive at 1207 N. Rangeline which is a business named Kneaded Relief. We did make contact with a subject identified as Barry Manthe. I did arrest Barry Manthe for two counts of failure to have a business license which is in violation of city ordinance 13-30. I did transport Mr. Manthe to the Columbia Police Department. While Mr. Manthe was being transported to the police department I did advise him of his Miranda Rights at approximately 1532 hours.

Upon arrival at the Columbia Police Department, I had an opportunity to run Mr. Manthe's name and date of birth through Joint Communications. Communications advised me that there was an outstanding warrant for Mr. Manthe's arrest. They stated the warrant was out of Curryville Police Department for the charge of failure to appear. They advised the bond amount on the warrant was \$500 cash only. The warrant number on this warrant was 98WJ031.

After getting confirmation on the Curryville warrant, I did arrest Mr. Manthe on the warrant. He was processed at the Columbia Police Department. After completing processing at the police department he did post a \$200 bond for the two counts of failure to have a business license. Mr. Manthe was then
