On 06-13-98 at approximately 1305 hours I was in the area of Broadway and Garth. I observed a brown Oldsmobile station wagon traveling in a east direction on Broadway west of Garth. I observed a white male driving in this vehicle. In addition I observed a white female passenger. I recognized the white male driver as being a Barry P. Manthe, date of birth 05-30-53. I had recalled from dealings with Manthe in the past that he did not have a valid driver's license to drive. I remembered from a prior arrest situation with Mr. Manthe that his driver's status was suspended through the Missouri Department of Revenue.

I did stop the vehicle in which Mr. Manthe was driving on the lot of the Daniel Boone Regional Library located near the intersection of Garth and Broadway. I made contact with the subject, Manthe, who provided me with a Missouri driver's license confirming his identity. I did run his driver's license through Communications and they advised me that his driver's license privileges were suspended according to Department of Revenue. They stated the suspension was for a failure to appear. They stated the Department of Revenue case number regarding this suspension was FA98011004. The effective date on this suspension was 05-12-98.

After learning that Mr. Manthe was suspended through Missouri, I did arrest him for driving under suspension. He was transported to the Columbia Police Department where he was processed. After completing processing, Mr. Manthe was transported to the Boone County Jail where he was held in lieu of posting bond on the driving under suspension charge.

The female subject which was riding with Mr. Manthe in the vehicle was identified as Cynthea Pemberton.

The vehicle was left in Ms. Pemberton's custody per the request of Mr. Manthe.
