On 07/11/98 I was conducting electronic surveillance of DET. CORNMAN. On this date we were conducting followup of complaints and information received about drug sale activity taking place at KNEADED RELIEF, located at 1207 RANGELINE RD. Information had been received that there was also prostitution taking place at this location and the girls working this location were selling crack cocaine. The operator of this location has been identified as BARRY MANTHE.

On 07/11/98 at approx. 1954 hours I was able to conduct surveillance and electronic monitoring of DET. CORNMAN. Contact was made with a suspect later identified as KIMBERLY M. LONG. I was able to here that there would be rock available and DET. CORNMAN could either wait or come back a little later. DET. CORNMAN left 1207 RANGELINE after it was agreed that she return in about 10 minutes.

On 07/11/98 at approx. 2013 hours CORNMAN returned to KNEADED RELIEF. During this contact I was able to here that the cocaine would have to be picked up. LONG and CORNMAN discussed how this transaction would be conducted. For details see report filed by DET. CORNMAN.

On 07/11/98 I followed DET. CORNMAN and a brown wagon displaying license # 359-AAY to the TEXACO located at COLLEGE & PARIS RD. Time of arrival at this location was approx. 2027 hours. I was able to monitor and observe LONG exiting the wagon and making contact with CORNMAN. A white male suspect later identified as GREG JOHNSTON left the area to pickup the crack cocaine. LONG remained with CORNMAN waiting for JOHNSTON to return. JOHNSTON was operating

the wagon as described above.

On 07/11/98 at approx. 2041 hours JOHNSTON returned to the TEXACO and made contact with LONG who then made contact with CORNMAN completing the delivery of one rock of crack cocaine which CORNMAN had paid \$20.

After the delivery CORNMAN cleared the area and I was able to still observe the above described wagon, now occupied again by both LONG and JOHNSTON. I then cleared the area to make contact with CORNMAN due to the two suspects remaining on the lot as if waiting to make contact with someone and both these individuals would know me and the vehicle I was operating due to past investigations. LONG has two possession cases pending at time of this undercover purchase made by DET. CORNMAN.

I later made contact with DET. CORNMAN and turned over to her the tape recording that I had been able to recover utilizing transmitting and receiving equipment. See report by DET. CORNMAN.
