On 07-16-98, I was continuing an ongoing investigation. As a result of the investigation, I purchased a twenty (\$20.00) dollar "rock" of "crack" cocaine from Cynthia M. Pemberton and Raymond L. Martin.

On 07-16-98, at approximately 2048 hours, I contacted Cynthia M. Pemberton at Kneaded Relief, 1207 Rangeline. Upon contacting Pemberton, I asked her if she had anything, meaning "crack" cocaine. Pemberton indicated that she could get some, and that she would go into the house and call someone. I remained outside of the residence, and while waiting for Pemberton, Barry Manthe came to the back door and made eye contact with me. At approximately 2049 hours, Pemberton came out of the residence and got into my vehicle with me. Pemberton then indicated that I needed to drive her to Park Street, Columbia, Missouri.

I then began driving Pemberton to the area she indicated, and during the drive, I engaged Pemberton in conversation as to who we would be looking for to purchase the "crack" cocaine from. Pemberton indicated that we were looking for "Reggie." Upon our arrival on Park Street, Pemberton instructed me to give her the money. I handed Pemberton twenty (\$20.00) dollars of Columbia Missouri Police Department money. Pemberton then instructed me to drive up the street, looking for "Reggie." After attempting to locate "Reggie," Pemberton then used my department issued cellular telephone and called the number 821-4151. Pemberton then spoke with a black male, "Reggie," that indicated he was standing at the corner of Park and Fifth Streets, Columbia, Missouri.

As Pemberton and I pulled up to "Reggie's" location, another vehicle stopped in front of my vehicle. This vehicle was bearing Missouri registration UCC-50. As the vehicle stopped and pulled to the shoulder, a large built black male stepped from the passenger side of the vehicle. "Reggie" then came to the passenger side window of my vehicle, and took the twenty (\$20.00) dollars from Pemberton. "Reggie" then walked to the driver's door of the vehicle that had stopped in front of us. Then, "Reggie" walked back to the passenger side of my vehicle, and he dropped a white crumbly chunk into the seat, between Pemberton's legs, at approximately 2058 hours. During the time "Reggie" was at the side of the other vehicle, Pemberton informed me that the black male that stepped out of the passenger side of the other vehicle was "E," the alias for Eric L. Hughes. After "Reggie" dropped the substance into the seat, Pemberton indicated to me that she had to get back to the residence at 1207 Rangeline. Pemberton indicated that she had a "trick" coming in a little bit, and she needed to get ready. Pemberton then placed the "crack" cocaine into her mouth until we reached the corner of Tenth Street and Rogers. Pemberton then placed the "crack" cocaine into the cup holder in the console of my vehicle.

As Pemberton and I traveled back to 1207 Rangeline, I engaged Pemberton in

conversation about the business of Kneaded Relief. Pemberton indicated that Manthe was "running" the business. Pemberton went on to say that the business was a "whore house." At approximately 2102 hours, I arrived at 1207 Rangeline and Pemberton exited my presence, thus completing the transaction.

Following the transaction, I performed a field test on the white crumbly chunk and obtained a positive result for cocaine. I then placed the "crack" cocaine into evidence at the Columbia Police Department. The "crack" cocaine will be sent to the Missouri State Highway Patrol Crime Lab for analysis. I also placed into evidence a microcassette tape, containing the conversation between Pemberton and myself, dated 07-16-98.

Raymond L. Martin was identified with the use of a photograph in the Columbia Police Department mug shot system. Pemberton was wearing a pair of shorts and a pink tank top. Martin was wearing a pair of white shorts, a yellow shirt, and a white hat.
