On 08/13/98, at 2253 hours, officers to include myself were dispatched to the area of 1207 Rangeline for the report of a disturbance in progress and possibly a firearm involved. Once I arrived at 1207 Rangeline, I contacted the victim, identified immediately as Cynthia M. Pemberton. I have had previous contacts with Ms. Pemberton and she then informed me that "Creol" beat her up. This is an alias or moniker for Christopher Haynes. Officers with the help of information given to the dispatcher located Mr. Haynes and placed him into custody at the location of Business Loop 70 East and Pannell Street. I then began the investigation by speaking with Ms. Pemberton. A witness contacted at the same time as Pemberton was the proprietor or owner of the Kneaded Relief Massage Parlor, a Barry P. Manthe. This was the location of the assault inside the massage parlor. According to Ms. Pemberton, Mr. Haynes began asking her for money. She informed him that she did not have any money and he began to become angry. She further informed me that Mr. Haynes has been hitting her and beating her for the past five days.

As the result of not having any money and the argument with Mr. Haynes, Ms.

Pemberton left the massage parlor with a friend and began to walk around. When she returned back to the massage parlor, Mr. Haynes confronted her and began pushing her into the business. He continued to want money in order to buy crack cocaine, when she did not produce any money, he began to beat her with his open hand across her face region. Pemberton described that she was struck in the jaw numerous times and she believed her jaw was broken. A witness to this incident was Barry Manthe who described the same incident involving Mr. Hayes striking Pemberton across the face numerous times.

Ms. Pemberton asked for assistance to the hospital and it was at this point that I communicated to Officer Jeff Forck who had arrested Mr. Haynes that there was probable cause to place him under arrest for third degree assault. I transported Pemberton to the University ER where she was evaluated. Ms. Pemberton did refuse x-rays of her head or upper body at the request of the emergency room. As the result of refusing any medical assistance at that point, she was evaluated briefly and given her release forms. I then transported Ms. Pemberton back to 1207 Rangeline. I supplied Pemberton with my business card with the case number for this report. Pemberton admitted to smoking crack earlier today. Both Haynes and Pemberton are known crack addicts. End of supplement.
