On 08-21-1998 I received a call from Barry Manthe who stated to me Christopher Haynes was at Kneaded Relief and Haynes had been given a trespass warning not to be at the residence. Manthe called at approximately 10:30 p.m. I was on a call and advised him I would be there shortly. Manthe called and stated Haynes left. Manthe then called back and stated Haynes was in the back yard of the residence. I went by the address and observed Haynes walking south near the corner of 8th and North.

I stopped and made contact with Haynes and advised him he was under arrest for trespassing. Haynes was cuffed and placed in the back of my patrol vehicle. Haynes stated Greg pulled into the back of Kneaded Relief and Haynes just walked away from there. However according to Manthe this was the second time Haynes had been there this evening.

Haynes was issued a trespass warning by Officer Roger Schlude on 08-14-98 after Manthe requested Haynes be given one for assaulting Cindy Pemberton who stays at the residence.

Haynes was transported to CPD where he was processed and taken to Boone County Jail.
