On 8-22-98 at approximately 1630 hours, I was contacted by an individual who wished to give me information concerning narcotics activities. This subject stated they had a large amount of information concerning the sales of, specifically, crack cocaine. I was advised that numerous subjects in Columbia and the surrounding area are selling crack cocaine, but will also occasionally deal in other narcotics.

I was advised that Bernard King is selling large amount of crack cocaine from Lot 61 in Rainbow Village Trailer Court. This subject stated that Bernard King normally transports the drugs in a black Infinity bearing Missouri license 025-BTB. The subject advised that if Bernard is driving this vehicle the drugs are normally in the trunk of the vehicle. The subject stated that if King is driving his green Ford Explorer bearing Missouri license 279-AHR, the narcotics are normally kept in the glove box. This subject advised Bernard King is selling out of Lot 61 Rainbow Trailer Court with a black male subject identified only as "Chaz." The subject stated Chaz lives in Trailer 61 of Rainbow Trailer Court. The subject stated Chaz normally has large amounts of crack cocaine in the residence and normally keeps it in one of the back bedrooms in the trailer.

The subject stated that a black male subject named Alex Carthron is selling crack cocaine from the Motel 6 on Providence Road. The subject stated Alex also is using a prostitute who goes by the name of Cee Cee to sell the narcotics. The subject identified Cee Cee as Crystal Marshall. The subject stated Marshall often goes by Tammy Marshall and has given the police that name in the past also. The subject stated that Alex is involved in the sales of narcotics along with Barry Manthe who is the owner of Kneaded Relief Massage Parlor.

The subject advised that Barry Manthe is selling large amounts of crack cocaine out of Kneaded Relief located at 1207 North Range Line. The subject stated people normally go to the back door of the business to obtain the narcotics. The subject stated that a black male named Creole, also known as Christopher Haynes, is selling crack cocaine for Manthe as well. The subject stated that there is a white male with the first name of Greg who is also involved in the sale of crack cocaine from Kneaded Relief. The subject did not know Greg's last name, but stated he drives an older, purple stationwagon.

The subject stated the next person that they wished to inform me of who is selling narcotics is Marcus Smith, also known as "Smitty." The subject stated that Smith is selling large amounts of crack cocaine out of his grandmother's house which is located on Wilkes Boulevard.

The subject stated that there is also a white male out of Mexico, Missouri who is selling large amounts of drugs. The subject stated Morris Noland is a large supplier of narcotics to the Columbia area.
