On 09/14/98 I made contact with the victim in this case, Mark TODD, reference to his reported auto theft. Upon speaking to Mr. TODD, he advised his car was indeed still missing. Mr. TODD advised that his nephew, Gary TODD, might have had keys to the vehicle, and he had heard "through the grape vine" that Sandra CALDWELL had possession of his vehicle. Mr. TODD advised that CALDWELL was the former girlfriend of his nephew, Gary TODD, and he had heard that CALDWELL now had his vehicle down at the Lake of the Ozarks.

Through researching the Columbia Police Dept computer system I determined Ms. CALDWELL had at one time worked for Barry MANTHE at the Kneaded Relief massage parlor located at 1207 Rangeline. I went to this location and made contact with MANTHE. Upon speaking to MANTHE, he advised he did indeed know CALDWELL. MANTHE stated he has not seen her for some time. MANTHE denied she still worked for him.

While I was at this location, I contacted Traci SAPP. Upon speaking to Ms. SAPP she advised she had heard from Gary TODD that Sandra CALDWELL had stolen Mark TODD'S vehicle, and she now had it at the Lake of the Ozarks. I left my business card with Gary and Traci and requested they contact me should they have any further information in reference this case.

I checked CALDWELL through the MULES computer system where I learned she had two outstanding warrants for her arrest. One was a Columbia municipal warrant for failure to appear on an original charge of improper lights and the other warrant is under her alias name of Sandra ELLIS and that warrant is out of Callaway County for fraud/insufficient funds checks. I prepared a wanted poster for dissemination within the department to other officers in reference to Ms. CALDWELL asking for their assistance in locating her.

Investigation continues.
