On 09-01-98, I met with CC, 98011729 and received information regarding the business aspect of Kneaded Relief. During my conversation with CC, 98011729, I learned that Barry P. Manthe is the manager of the "house." I also learned that Manthe is paid for every "client" coming into the business. Manthe provides rooms for the women, and is paid twenty dollars (\$20.00) per "client." The "clients" are customers of prostitution. According to CC, 98011729, there are no women working in Kneaded Relief that know how to actually provide massages. The women are all using drugs in front of Manthe, some customers, and with some customers. According to CC, 98011729, Manthe knows every customers, and how much each customer is willing to pay for the prostitution services offered at Kneaded Relief. CC, 98011729 also informed me that Manthe instructs the prostitutes on the type of vocabulary that they should, or should not, use while in the presence of the customer.
