The police department has been receiving ongoing information about a suspect identified as BARRY MANTHE running prostitution locations under different names and locations here in COLUMBIA, MISSOURI. Citizen complaints along with intelligence information identified MANTHE as promoting prostitution here in COLUMBIA. Upon being reassigned back to the narcotics unit in OCTOBER of 1997 I again began receiving information about MANTHE being involved in promoting prostitution and sales of controlled substances on the premises he operates. An example of documented activities for background information is the investigation of the "BLUE ROSE" located at 1203 N. GARTH. Two different search warrants were served at this location, both resulting in the recovery of controlled substances and arrest were made. These were on 4/24/98 and 05/28/98. On both these occasions KIMBERLY LONG was arrested. On 05/28/98 while conducting evidence documentation I spoke with LONG. She admitted to me being a prostitute and working for BARRY MANTHE in the past and at the present. She went on to tell me that MANTHE runs the "BLUE ROSE". She went on to tell me that MANTHE gets a fee from her for every customer she does at the house.

I conducted a business license check and located MANTHE having business licenses in the past under the names CAMELOT ACCUPRESS MESSAGE, PHOENIX MESSAGE STUDIO, and at the present KNEADED RELIEF. This location was originally at 1203 JEFFERSON but shows an address change to 1207 RANGELINE. All the above businesses have been identified as outlets for prostitution and drug abuse and sales activities. MANTHE never shows to have had a business license for the BLUE ROSE but it was common knowledge that he was operating that location even before the interviews of prostitutes arrested on 04/24/98 and 05/28/98 who identified MANTHE as running the house.

During the course of my followup I had contact with CHARLES PERRY, of the

CRIMINAL DIVISION of the INTERNAL REVENUE SERVICE. He was aware of BARRY MANTHE and his involvement in running houses of prostitution here in COLUMBIA. I received further background information on how the house would operate and how MANTHE would try to protect himself from prosecution.

After conducting background and linking known prostitutes to the MANTHE operation I utilized DET. CORNMAN to make undercover contacts and enter into the inner circle of prostitutes working at the 1207 RANGELINE location. Our investigation at time of this report resulted thus far in the purchases of "crack" cocaine on multiple occasions from prostitutes working at the 1207 RANGELINE location operating under the name of "KNEADED RELIEF". The business license shows in the name of BARRY MANTHE. Direct contacts with MANTHE have been made by DET. CORNMAN, in an undercover capacity to firm up his direct involvement in the prostitution activities that are being conducted with his knowledge and direction. This was done also to show how MANTHE is profitting from the promotion of prostitution on the premises. He has been present during drug sales activities and during the prostitution activities. This has been documented by DET. CORNMAN and I over the past several weeks.

The following paragraphs will be a synopsis of this investigation that documents the drug activities and the promoting prostitution activities of the primary suspect BARRY MANTHE at 1207 RANGELINE, "KNEADED RELIEF".

On 07/11/98 DET. CORNMAN made contact with KIMBERLY LONG and CYNTHIA PEMBERTON at 1207 RANGELINE, KNEADED RELIEF. She was allowed entry at this location by BARRY MANTHE. As a result of this contact originating at this location a purchase of crack cocaine was made away from this address by DET. CORNMAN from KIMBERLY LONG. Case # 98-009011.

On 07/16/98 DET. CORNMAN made contact with CYNTHIA PEMBERTON at 1207 RANGELINE, KNEADED RELIEF. While at this location BARRY MANTHE was witnessed to be present. As a result of this contact crack cocaine was purchased away from this location. DET. CORNMAN made the purchase from PEMBERTON and the second suspect was identified as RAYMOND MARTIN. After the transaction DET. CORNMAN had conversation with PEMBERTON about the business at KNEADED RELIEF. She told CORNMAN that it was a "whore house" being run by BARRY MANTHE. This is filed under case # 98-9265.

On 07/17/98 DET. CORNMAN made contact with BARRY MANTHE at 1207 RANGELINE, KNEADED RELIEF. DET. CORNMAN asked MANTHE if "K" (KIMBERLY LONG) was around. MANTHE turned and called to LONG. This contact resulted in the purchase of crack cocaine from LONG and a second suspect identified as GREG JOHNSTON away from the 1207 RANGELINE, KNEADED RELIEF location. The large rock of crack cocaine was broken-up at 1207 RANGELINE, KNEADED RELIEF, in a rear bedroom. MANTHE was present during the original conversation about wanting to purchase

\$100 worth and was present when LONG, JOHNSTON, and DET. CORNMAN returned to this location to break-up a larger rock to give DET. CORNMAN her \$100 worth of crack cocaine. This case is filed under 98-9332.

On 07/24/98 DET. CORNMAN made contact with GREG JOHNSTON at 1207 RANGELINE, KNEADED RELIEF. As a result of this contact a purchase of \$100 worth of crack cocaine was made by DET. CORNMAN from suspects LONG, JOHNSTON, and RAYMOND MARTIN. The purchase was made away from the 1207 RANGELINE. While DET. CORNMAN was at KNEADED RELIEF, BARRY MANTHE was present along with two white females and two black males names unknown. While DET. CORNMAN was at the residence a white male showed up and began speaking with MANTHE. The male asked for "SANDY" and asked if she was with a "client". This case is filed under # 98-9691.

On 08/12/98 DET. CORNMAN made contact with CYNTHIA PEMBERTON at 1207 RANGELINE, KNEADED RELIEF. A purchase of \$20 worth of crack cocaine was made from PEMBERTON. This purchase was away from the business. During this transaction DET. CORNMAN had conversation with PEMBERTON about being interested in making extra money. PEMBERTON told her that she could make good money at KNEADED RELIEF. She went on to tell DET. CORNMAN that she could charge \$100 per "client" and that BARRY only got \$20. PEMBERTON told DET. CORNMAN that all she needed to make this money was alot of condoms. This transaction is filed under case # 98-10653.

On 08/15/98 DET. CORNMAN made contact with CYNTHIA PEMBERTON at 1207 RANGELINE, KNEADED RELIEF. As a result of this contact \$50 worth of crack cocaine was purchased from PEMBERTON. This purchase was away from KNEADED RELIEF. This case was filed under # 98-10819.

On 09/01/98 DET. CORNMAN met with a C.C. and received information regarding the business aspect of KNEADED RELIEF. BARRY MANTHE was identified as the manager of the "house". It was further learned that MANTHE is paid for every "client" that comes into the business. MANTHE provides the rooms to the women and is paid \$20 per "client". The "clients" are customers for prostitution and none of the women working at KNEADED RELIEF would know how to give a message. Drugs are openly used by the women working there and the customers also are involved in drugs. MANTHE is fully knowledgeable about the drug use going on at the business. According to the C.C. MANTHE knows all the customers and what they are willing to pay fpr prostitution services rendered at KNEADED RELIEF. MANTHE also instructs the prostitutes on the type of words they should use and not use in the presence of customers. This information is filed under case # 98-12384.

On 09/15/98 DET. CORNMAN went to 1207 RANGELINE, KNEADED RELIEF. Contact was made with a suspect identified as DOROTHY TWYLA KEE. A purchase of \$30 worth of crack cocaine was made at this location. Also at this location on this date was

BARRY MANTHE. On this date I had directed DET. CORNMAN to have direct conversation with MANTHE about becoming a prostitute at KNEADED RELIEF. DET. CORNMAN had been frequenting this location for several weeks and it was felt that MANTHE may becoming used to her being around. Also we had received information from PEMBERTON on 08/12/98 during a undercover contact when she offered to enlist DET. CORNMAN to go to work for MANTHE at KNEADED RELIEF, when questioned about how the money was. Again this is filed under # 98-10653.

On 09/15/98 DET. CORNMAN had direct conversation with BARRY MANTHE about going to work for him at KNEADED RELIEF. During this conversation MANTHE told DET. CORNMAN that he got \$20 for each "client". MANTHE had a "client" today if she wanted to start now. MANTHE explained that this "client" who usually takes the employees to motels and pays the girls \$200 and \$40 to him (MANTHE). For particular details of this contact with MANTHE see attached case # 98-012381 which details the prostitution activity documented on this date. Also see case # 98-12382 which documents the drug sale at KNEADED RELIEF on this date. (attached)

After compiling the above information documenting drug activity and prostitution activity this case file is being forwarded to the BOONE COUNTY PROSC. OFFICE for review and request for presentation to GRAND JURY. An indictment is being sought on the primary suspect BARRY MANTHE, for PROMOTING PROSTITUTION in the SECOND DEGREE. Reference to the documented drug sales activities these cases are also being presented for indictments on the individuals identified in each of the sales cases.
