On 09/05/98 I had contact with DEBRA COLEMAN during a prostitution sting conducted by members of the NARCOTICS UNIT. During this contact COLEMAN told me she used to work for BERRY MANTHE, at KNEADED RELIEF. She went on to tell me that the location is at 1207 RANGELINE. COLEMAN told me that this location is a "WHORE" house which MANTHE runs. COLEMAN also told me that there is cocaine and marijuana being sold at this location. She stated that MANTHE lets the girls and customers buy sell and trade for sex, cocaine at this location. She went on to tell me that MANTHE sells marijuana at this location and lets the girls handle the cocaine. She went on to tell me that MANTHE usually keeps a quantity of marijuana buried in the backyard at the above location for sales to costumers that he knows are ok.

COLEMAN went on to tell me that MANTHE collects a house fee from the girls and the girls keep the rest. The house fee runs about \$20 a customer but sometimes more depending on the customer and what all he wants. She confirmed that sex is for sale in any way you want it and MANTHE runs the house and collects fees for services rendered. COLEMAN told me she decided to start her own outcall service and operate out of motel rooms so she could keep all the money. She has a steady business from regular customers that come to COLUMBIA at least a couple times a month.

Reference to this case file information it is presently being followed up by DET. CORNMAN and I and upon completion a case presentation will be presented to GRAND JURY. An indictment will be sought under CHAPTER 13, MO. CRIMINAL CODE, PROMOTING PROSTITUTION in the SECOND DEGREE (567.060) CLASS C FELONY.
