On 09-21-98 at approximately 1442 HRS, I was traveling eastbound on Broadway approaching Fifth. As I approached the stoplight in front of me, I observed a yellow colored Ford Fairmont with a temp tag which had an expiration date of 08-13-98. The suspect vehicle then turned left onto Fifth now heading northbound.

As I looked at the driver, I recognized the driver as one Traci Gene Sapp. I also noted the vehicle was occupied by one Barry Manthe. I then proceeded to follow the vehicle which continued northbound on Fifth Street. As the vehicle approached Ash, it made a right turn now heading eastbound.

I followed the vehicle several blocks until it pulled into the driveway of Kneaded Relief which is located at 1207 Rangeline Street. I then observed the driver and the passenger exit the vehicle. At this time, I was again able to identify Ms. Traci Sapp as the driver of the vehicle. Ms. Traci Sapp and Mr. Barry Manthe exited the vehicle and walked into the business.

Approximately two to three weeks prior to this date, I had pulled over a vehicle in which Ms. Traci Sapp was an occupant. After running Ms. Sapp through Communications, I had recalled her driving status was revoked. I then ran Ms. Sapp through Joint Communications on this date and time and again was
