On 09/21/98 I conducted visual and electronic surveillance involving a suspect identified as BARRY MANTHE, owner/operator of a message parlor, "KNEADED RELIEF". The location of incident is 1207 RANGELINE, COLUMBIA MISSOURI, BOONE COUNTY.

On this date I was able to witness DET. CORNMAN arrive at the above location. I was also able to monitor DET. CORNMANS activity utilizing a KEL-UNIT transmitter and receiver. I operated recording equipment to document her contact between her and BARRY MANTHE. For details of this investigation on this date see report and tapes reference this contact and transaction.

I was able to witness (audio) DET. CORNMAN paying MANTHE \$40.00 for the use of his house to conduct prostitution activities. This was a fee that he had quoted to DET. CORNMAN. This was paid to MANTHE with official police funds, of which photo copies had been made documenting the serial numbers.

On 09/22/98 during the booking of MANTHE after his arrest on two counts of PROMOTING PROSTITUTION in the 2nd DEGREE, I observed that MANTHE had a large sum of money on his person. I asked MANTHE were he had gotten the money from and he told me he had been saving it and he got it together for his bond money. MANTHE went on to tell me that he had just picked up the money but would not say from where. I asked him if he used a ATM machine and he told me that he had not. I then in his presence compared the serial numbers and located a \$20 bill that I had photo copied on 09/21/98. This was one of the bills used to pay MANTHE as described above. I then had OFFICER BEN WHITE seize the entire sum of money as evidence since the police funds were contained within. For total of funds seized see report by OFF. BEN WHITE.

MANTHE was arrested under the GRAND JURY INDICTMENT, and a second count as a result of the contact on 09/21/98.
