On 01/18/14 at approximately 0502 hours I was dispatched to a trespass subject at 1125 Vandiver. The complainant Ronald Clark wanted a black male subject by the name of Marco to leave.

Upon arrival I made contact with Clark who stated Marco would not leave. We then made contact with a black female and a black male in a northeast bedroom. I asked for ID from the male who gave me a MO ID. He was ID'd as Marco Campbell. I advised Campbell he was being issued trespass warning for the residence.

I then asked for the black females' ID, she asked why and I told her I needed to identify her to give her a trespass warning. The female would not give me her name, I asked her if she was wanted and if that was why she did not want to give me her name.

Officer Blake, who was assisting me, stated he knew her as Shalamar Holden-Wilkerson and she probably did have a warrant for arrest. Officer Blake advised Holden-Wilkerson was known to use drugs.

Officer Blake who was standing next to Holden-Wilkerson near the bed, saw what looked to be a needle sticking out of Holden-Wilkerson's purse which was laying open on the bed. Officer Blake asked Holden-Wilkerson if he could look in her purse and she gave him permission. Officer Blake found drug paraphernalia in Holden-Wilkerson's wallet. Officer Blake placed handcuffs on Holden-Wilkerson and advised her she was under arrest for Possession of Drug Paraphernalia.

Campbell was escorted off property. As we were escorting Holden-Wilkerson out of the house she told us she was not going with us because she did not do anything. Wilkerson started fighting us, refusing to step forward towards the front door to the outside. As we were trying to get Holden-Wilkerson into the vehicle, Holden-Wilkerson kicked Officer Blake in the groin area with her foot. Holden-Wilkerson was placed in the rear seat of my patrol vehicle and I transported her to the Columbia Police Department.

Holden-Wilkerson was fingerprinted, photographed and allowed to make phone calls to post bond. As I was inventorying Holden- Wilkerson's purse, I located in the wallet;

- 1) 1 syringe with needle.
- 2) 1 blue pill, identified as Viagra.
- 3) 1 blue pill, identified as Morphine Sulfate.
- 4) 1 metal spoon with white residue.
- 5) 1 plastic spoon with white residue.
- 6) 1 small plastic baggie of white residue.

The metal spoon and white powder in the plastic baggie was tested for Methamphetamine and the tests came back positive for that substance.

Holden-Wilkerson committed the crime of Possession of Controlled substance, RSMO 195.202 by having in her possession, the Morphine pill and white substance, Methamphetamine; Resisting Arrest, RSMO 575.150, by refusing to follow officer commands; Third Degree Assault LEO, RSMO 565.070, by kicking Officer Blake; Possession of Drug Paraphernalia, RSMO 195.233, by having two spoons and one syringe for illegal drug use.

Holder-Wilkerson was transported to the Boone County Jail for bonding purposes and was left in the custody of jail personnel.
