On 06/19/2014, at approximately 1850 hours, Officers Rob Smith, Rick Mabe, and I were assisting VNOG and Street Crimes with a prostitution/human trafficking investigation in the area of 915 Port Way, the Holiday Inn.

I was assigned to the perimeter of the hotel, to locate any further suspects, involved with prostitutes as they arrive and enter the motel itself.

Sergeant Harlan Hatton contacted me by phone and informed me that the female he was in contact with was placed under arrest for Prostitution. I was further informed that she indicated that the suspect that provided her a ride was possibly outside on the motel parking lot. A description was given of the vehicle and the fact that a white male was inside the vehicle. Officer Rick Mabe was conducting surveillance in the parking lot and was asked to drive through the lot where he observed the possible suspect. Officer Mabe observed a silver 97 Chevy Lumina parked on the north parking lot of the motel that was occupied by a white male wearing glasses. Mabe provided me a license plate number for that vehicle, which was registered to a Barry Manthe. I am aware that for many years, Mr. Manthe is a known procurer of prostitution. We detained Mr. Manthe and it was confirmed through Sergeant Hatton that he was to be arrested.

We conducted a search of Mr. Manthe's vehicle for evidence of prostitution, with no evidence seized. The vehicle was locked and secured at the location where Mr. Manthe was occupying it.
