On 5/24/2016 at approximately 2200 hours, I was dispatched to make phone contact with Robert Dore to follow up on the vehicle theft. Dore advised the

suspect in the theft, Glen Robinson, informed him the vehicle would be returned at 1900 hours. Dore stated the vehicle was not returned to him.

Dore informed me Glen's mother and girlfriend knew where the vehicle was located. Dore also stated Tammy Skaggs had been spreading rumors that the vehicle was within 6 miles from Colonial village.

I went to 2904 Range Line St Lot 14 to speak to Glen's mother, Rita Robinson, and girlfriend, Georgia Trejo. When I arrived, I found that Tammy Skaggs was also in lot 14. I first spoke with Trejo and Skaggs. Both stated they did not know where Glen was or where he stayed. I asked Trejo why she did not know where her boyfriend lived and she stated Glen did not like to share information with her.

I next spoke with Rita who also stated she did not know where the vehicle or Glen was located. Rita advised Glen does not tell her where he lives because she worries too much about him. Rita stated she didn't believe Glen stole the vehicle and heard that the original owner of the Yukon gave Glen permission to take the vehicle. Rita advised she heard rumors that Dore owed money on the vehicle and was not paying, so the original owner allowed Glen to repossess the vehicle.

Rita, Skaggs, and Trejo could not provide me with a phone number for Glen. All three stated they had not heard from Glen all day. Rita did not state where she heard the rumors of the repossession from. Skaggs stated she did not know the location of the vehicle or if it was near the trailer park.

I next spoke with Glen's brother, Russell Robinson, at lot 27. Russell also stated he had not heard from Glen. Russell also informed me the previous owner of the vehicle gave Glen permission to take the vehicle. Russell stated the old owner that sold the vehicle to Dore was Robert Matthews. Russell provided me with a phone number for Matthews of 573-289-2158.

I made contact with Matthews by phone. Matthews stated he sold his vehicle approximately two years ago to a friend of his son. Matthews stated there have been no problems with the payments. Matthews he has not requested anyone to take the vehicle from Dore.

I next went to 1125 Vandiver Dr to speak with Barry Manthe. The vehicle was originally taken from this location. Manthe stated he did not witness the theft but knew Dore and Glen had an argument outside. I had previously read the original report and asked Manthe if he knew the female identified only as Ebony. Manthe stated Ebony was in the back room.

Ebony walked into the living room and I identified her as Toni Taylor. Taylor

stated she was never in the vehicle with Glen. Taylor stated she called a tow company to tow Dore's vehicle because it was blocking Manthe's driveway. I asked Taylor where she had been all day and Taylor informed me she was with a friend. I asked Taylor if I could speak to the friend. Taylor directed me to her room where she searched her phone for the friend's number. Taylor informed she could not find the number in the phone and did not know the friend's name.

I could hear Manthe in the living room speaking to someone and stating that Taylor was lying. I went to speak to Manthe again and he directed me to another room where Taylor could not hear. Manthe stated Taylor was lying to me and he was confident she was with Glen on this date.

I asked Manthe if he knew anymore about the theft. Manthe stated he heard the vehicle was taken over a drug deal. Manthe stated Glen was angry because Dore sold him bad dope. Manthe stated Glen was demanding money from Dore before Manthe left to go back inside.

I called Dore again to verify he observed the black female he knew as Ebony in the vehicle. Dore advised she was in the vehicle with Glen. I returned to Taylor and informed her she was under arrest. I placed Taylor into handcuffs which were checked for tightness and double locked.

I transported Taylor to the Columbia Police Department for processing. At the Columbia Police Department, I read Taylor her Miranda Rights. Taylor stated she understood her rights and would speak to me.

I asked Taylor about the theft of the vehicle. Taylor stated she was never in the vehicle and did not see Glen steal it. Taylor stated she went inside because she believed Glen was going to shoot Dore. I asked Taylor why Glen would shoot Dore. Taylor stated she did not know but advised Glen told her to go inside while he was talking to Dore. Taylor stated based on Glen's demeanor and the tone of his voice she believed Glen was going to shoot Dore. Taylor stated Glen does own a gun but she did not see it. Taylor stated she could hear the car alarm of Dore's vehicle going off when she was inside.

Taylor stated she did not think the vehicle was stolen. Taylor stated she called Tiger Towing to tow Dore's vehicle but when the tow arrived she requested them to wait. Taylor stated she was told the owner or friend of the owner was coming to get the vehicle. I contacted Tiger Towing and asked if they responded to 1125 Vandiver Dr. The employee of Tiger Towing stated he found no record of a tow or call to that address.

Taylor advised me she had only gone to the Midway hotel on this date to meet a client. Taylor advised the client never showed up and she came home. Taylor stated Glen was not staying at the Midway and did not know if he was staying at

another hotel.

Taylor provided me with a phone number for Glen of 573-242-2425. I have been unable to contact Glen at this time. Taylor advised she did not know where Glen would be and he does not tell her where he is staying.

Taylor was written summons 150814001 in violation of RSMO 569.090 for second degree tampering for unlawfully riding in another's automobile. The court date for the summons was 7/7/2016 at 1330 hours. Taylor signed the summons and was given a copy. Taylor was cooperative throughout processing.
