INCIDENT NARRATIVE

DISTURBANCE REPORTED IN THE 1100 BLK OF VANDIVER DR

NARRATIVE

On 11/07/2016 at approximately 2016 hours, I arrived at 1125 Vandiver Drive, reference to a trespassing.

Upon arrival, I contacted Daniel Stewart who advised a female who resides at 1125 Vandiver Drive, assaulted him by spraying him with mace as he was sitting outside of that residence. Stewart also advised he believed he was tased by that same female on his neck. Stewart was very incoherent with his

statements, was emotional and appeared very upset. Stewart was uncooperative with officers and advised he wanted us to shoot him. Stewart was taken into custody under a separate case number, 2016-012292.

I spoke with the female Stewart was referencing, Toni Taylor, who advised Stewart who was an acquaintance of hers came over to the residence requesting to have sex with her and when she refused he became upset and tried to break in her room at that residence. I observed damage to both doors to Taylor's room.

Barry Manthe and Ronald Clark were present during some of the incident. Clark was the original caller who advised Stewart was trespassing and stated he was in the kitchen when he heard what he believed to be Stewart attempting to break into Taylor's room. Both Clark and Manthe advised Stewart was very unruly when they tried to get him to leave. Manthe also stated Stewart pushed him down outside causing him to scrape his knee. Both Manthe and Taylor advised they did not wish to pursue any charges against Stewart for property damage or assault, but just wanted him trespasses from that residence.

In reference to the alleged pepper spray, Taylor advised when Stewart was able to break down one of the doors to her room, she did indeed spray him with mace that was attached to her keyring and then exited the residence to get away from him.

I responded to UMC ER to speak with Stewart further about the incident. Upon arrival, Stewart was restrained on the hospital bed and still did not appear to be in the proper mental state to give an accurate statement about the incident as he was talking about unrelated topics. I did take photographs of Stewart to include the neck area where he stated he was tased.

This incident was reported due to Stewart wanting to press assault charges against Taylor, however, I will not make any arrests due to Taylor's statement and the witness statements advising Stewart to be the primary aggressor and no body wanting to pursue charges against Stewart.

This case should be considered unfounded.
