On 3-21-95 at 0315 hours I was dispatched to 1117 Vandiver Drive in reference to a fraud. Prior to my arrival I was informed the complainant stated he had paid the business \$120.00 for services not rendered and was demanding his money back. This business is Camelot Massage.

Upon arrival I made contact with the complainant who was identified as David Wayne Tye. While speaking with Mr. Tye, Mr. Tye was very intoxicated. Mr. Tye stated he had come to the business, paid \$120.00 to "get lucky". Myself and Officer Striegel asked him what this meant and he then stated he had gone to the massage parlor to "get laid". While speaking with Mr. Tye, Mr. Tye stated he had gone in and had chosen the girl he wanted and he had chosen a white caucasian girl who had brown hair. He could not remember her name, nor could he remember any other description of her. Mr. Tye stated she had taken him into a room and that she had gotten on top of him and she had been there for fifteen minutes. Mr. Tye then went on to state after fifteen minutes was up she said that his time was up and left the room. Mr. Tye stated he was not satisfied with this and went out to the office area and started demanding his money back. Mr. Tye went on to state him and the assistant manager, who was identified later as Randall Bowers started arguing at which time Tye states that Bowers threw him across the room several times.

Mr. Tye later stated he was brought up that if you get "screwed" you fight. Mr. Tye went on to state he felt he had been "Screwed" and he was going to stand his ground. I then asked Mr. Tye if he understood the business had requested him to leave and he had refused to leave. Mr. Tye went on to state that it doesn't matter he did not get what he paid for. I again asked Mr. Tye what did he mean he did not get what he paid for and Mr. Tye stated there was no penetration, that when the girl got on top of him all she did was give him a hand job and that he was not satisfied with that.

After speaking with Mr. Tye Officer Striegel and Officer Brotemarkle went into the business and spoke with the occupants in the business. Officer Striegel then returned stating to myself and Mr. Tye that Mr. Bowers had stated he had requested Mr. Tye leave the business and Mr. Tye refused to leave. Bowers stated Tye stated he wanted his money back and he wasn't leaving until he got it and started kicking the doors and other items in the business. After Officer Striegel told me this Mr. Tye then informed us that he did not want to press charges.

Mr. Tye then went on to state the girl he had given the money to was in the house and he wants to know if he can get his money back. Officer Brotemarkle then stated he would go inside and see what he could do. Officer Brotemarkle then went back inside the business and made contact and asked if this person was here and was informed the female goes by the name of Sunshine and her real name is Connie Bowers. This is the estranged wife of Mr. Randall Bowers. Mr.

A cab was contacted for Mr. Tye for transport to his residence which is on Steamboat.
