On 06-30-96 at approximately 1547 HRS, I was on routine patrol in the area of 210 Anita Court. At this time, I was flagged down by a white female who identified herself as KAREN CONNELL. Ms. Connell stated that she wished to pass on information reference drug activity at 210 Anita Court.

As Ms. Connell was speaking with me, she spoke very softly and asked me to meet her around the corner and out of sight to further speak with me. Ms. Connell was concerned that the residents of 210 Anita Court would see her speaking with me.

Ms. Connell stated that she resides at 211 Anita Court, apartment #11. Ms. Connell states that her apartment faces 210 Anita Court. Ms. Connell states that during the evening hours she observes a large amount of vehicular traffic in and out of 210 Anita Court. Ms. Connell states that on one occasion she has observed a black female, who she believes is DEBRA SUE HICKEM, conduct drug deals in plain view outside 210 Anita Court.

Ms. Connell states she has observed this female place small bags of white substance on the hood of vehicles. Ms. Connell states she then observed hand-to-hand transaction with these baggies. Ms. Connell states she has observed black males enter the residence of 210 Anita Court with briefcases. Ms. Connell states they then leave the area in the same vehicle. Ms. Connell states she has observed this on several occasions. Ms. Connell states that her neighbor, who resides at 211 Anita Court, apartment #10, is also involved with the residents of 210 Anita Court.

Ms. Connell states that her neighbor's first name is DONNA, most probably DONNA BROWN. Ms. Connell states that there are other residents on Anita Court who are involved with this drug activity. Ms. Connell states that AL TOLBERT and his girlfriend are also involved. Ms. Connell states that a female, who she knows by the first name of SHARON, frequents 210 Anita Court in a light yellow older vehicle bearing Missouri registration. Ms. Connell states that this female conducts frequent trips in and out of 210 Anita Court. The registration checks to a SHARON RUSH.

Ms. Connell states that she believes one of the landlords may also be involved in this drug activity. Ms. Connell states that CAROL BENNETT is an assistant manager of the complex and is a friend of hers (Karen Connell). Ms. Connell states that Ms. Bennett is aware of the suspicious activity on Anita Court. Ms. Connell states that Ms. Bennett has stated she would be willing to let officers surveil the area from her residence. Ms. Connell stated she would also let officers surveil the area from her residence.

Ms. Connell states that the residents of 210 Anita Court know that the police are now watching the residence. Ms. Connell states that Ms. Hickem had

been to Ms. Bennett's office to pay rent. At that time, Ms. Connell states that Ms. Hickem told Ms. Bennett to "stay out of my business." Ms. Connell states that Ms. Hickem told Ms. Bennett someone would be getting hurt if they did not stay out of her business. Ms. Connell states that she is in fear of her safety as well as the safety of children in the area.

On 06-29-96, I had been patrolling the area of 210 Anita Court. At that time, I was flagged down by a black male. The black male asked if there were any problems in the neighborhood. I advised him that I was just taking a break. The black male stated that he had a daughter who lived up the street and was concerned that there may be some problems in the area.

Ms. Connell states that she observed me speaking with this subject on that day. Ms. Connell stated that after I left the area, this black male walked directly over to 210 Anita Court and spoke with the residents there. Ms. Connell stated that he then spoke with her neighbor as well as another residence on Anita Court. Ms. Connell states she believed he was telling the residents that I had been in the area.

Ms. Connell provided me with a list that she has been keeping of vehicles that frequent the area. I have entered these vehicles in this report. Some of the registered owners and their associates have prior arrests reference drug activity. Some of the vehicles on the list were not on file through the Department of Revenue.

Ms. Connell stated she had additional information reference this activity and had further lists to provide to me. I left my business card with Ms. Connell and asked her to call me with further information.

No further at this time.
