NARRATIVE

At 23:30 hours, 09/03/96, I was dispatched along with Officer Schwartze to 1203 Jefferson in reference to a verbal disturbance. We subsequently were advised while en route, the disturbance involved a Donna BROWN. Upon our arrival at the residence, we made contact with a Barry P. MANTHE.

At this time Mr. MANTHE stated that Donna BROWN had been there, and she had assaulted him, but now had left. At this time I noted Mr. MANTHE had an abrasion to his forehead and an abrasion to his lower lip. He then showed to me his mouth which was missing 3 upper teeth in the front. Mr. MANTHE then stated Donna BROWN had struck him with her high heel shoe in the head and mouth causing the injury. He then pointed out to me a white womans high heel shoe lying on the sofa. He stated she had used this. Mr. MANTHE at this time stated he was not going to seek treatment. He stated he did not know where Donna BROWN was going and stated he had not seen her in some time as she had been in rehab in Hannibal. He stated she came to the residence and was very intoxicated and started arguing with him and stated something to the effect that he treated the other girls better than her. It should be noted that Mr. MANTHE and Ms. BROWN are prior associates in the Camelot Massage Parlor and at 1203 Jefferson the same type of operation has been undertaken at this time. He stated while BROWN was arguing with him, she became very upset and struck him with the shoe. At this time MANTHE stated he did not know for certain what to do but stated he did not want prosecution on Ms. BROWN at this time. He stated he was declining prosecution. He stated he would like to have her issued a trespass warning for the residence as he did not want her to come back. He stated it had been some time since he had seen her and does not know why she came to the residence on todays date. He stated he did not strike her or harm her in any way. It should be noted as near as I could tell, though Mr. MANTHE and Ms. BROWN were prior business associates, there was no domestic violence at this time as it did not fit the criteria. As stated, Mr. MANTHE declined prosecution at this time.

Officer Schwartze had responded to the area and checked the area with negative results for Ms. BROWN on foot in the area at this time. There were not witnesses to the offense at this time. I took the shoe pointed out by Mr. MANTHE as inflicting the injury to him into evidence and did observe smears of

what appeared to be blood on the heel portion of the shoe. This shoe will be placed into evidence.

It should be noted at the time I took the original report from Mr. MANTHE, I did not believe this to be domestic violence. Mr. MANTHE also at this time did not supply information in reference to this and also stated he did not want prosecution. I have since learned that Mr. MANTHE and Ms. BROWN have a child together, thus this would fall under the domestic violence statutes of the state of Missouri. I will also apply for a warrant for Ms. BROWN'S arrest in reference to this for assault. I did not photograph Mr. MANTHE'S injuries at the time as I did not believe it to be domestic violence, and also since he was declining prosecution. But as stated, I gained other information later that they in fact have a child in common and it would be domestic violence. Therefore, a warrant will be requested for Ms. BROWN'S arrest.
