On 10-22-95 at about 7:34 p.m., Joint Communications received a telephone call from a Mr. Wayne Stowers in reference to prostitution going on at the Camelot Massage Parlor. Mr. Stowers stated he would like to make contact with an officer by public service at . . . Joint Communications then gave me that information.

I then made contact with Mr. Stowers by public service who stated on this date, at about 7:00 p.m., he went to the Camelot Massage Parlor to try and set up a white female subject who works there for prostitution. Mr. Stowers went on to state that about three weeks prior to this date, a friend of his who is in the process of being married, went to Camelot Massage Parlor and paid to have sex with a white female subject who works there as a masseuse. Mr. Stowers stated sometime during sex, the female subject then hurt his friend by grabbing ahold of his penis and bruising it. Mr. Stowers stated that this "pissed him off," and he was going to pay them back for it.

Mr. Stowers stated he then marked five \$50 bills with an "X" in the upper left-hand corner of the bill to prove the money was his. Mr. Stowers stated he then went inside Camelot and talked to a black female subject who stated, she worked there. Mr. Stowers stated the female subject then led him to one of the rooms at which time she told him that the room cost \$20 and that would be for the cost of the room and the massage. Mr. Stowers then told him that a hand job would cost him \$60. A blow job would cost him \$80. And, combination would cost \$100.

Mr. Stowers stated he then asked the black female subject if she was the only one working at which time she stated, "Yes."

Mr. Stowers stated that he then decided to leave and contact the Columbia Police Department to report prostitution.

Mr. Stowers also stated that there was a male subject sitting in the front lobby area of the business watching TV while this was going on. Mr. Stowers stated that he is very concerned about this and would like officers to investigate it further.

I then asked Mr. Stowers for his name and address at which time he gave me his name, but refused to give me his address as he stated he did not want to become involved in any court situations.

I then advised Mr. Stowers that I would do a report and I would also go to the Camelot Massage Parlor and talk to the occupants at that location.

Officer Thomason and myself later went to Camelot Massage Parlor and talked to three individuals who were present. I first make contact with a black female subject who told me her name was Donna Brown. I advised Ms. Brown why we were there, at which time she stated that she remembered Mr. Stowers coming in and was acting very strange. Ms. Brown stated she then advised Mr. Stowers that a massage would cost him \$20 at which time he then asked her if she was the only one working. Ms. Brown stated that she was and if wanted a massage, that she would be the only one to give it to him. Ms. Brown stated that Mr. Stowers then reached out for her at which time she pushed him away and then told him he needed to leave.

I then made contact with a Ms. Connie Munton who stated she worked there but was not present while Mr. Stowers was at the business.

I then made contact with a Barry Manthe who stated he was in the front room watching TV when Mr. Stowers came in. Mr. Manthe stated that he could not really remember all of Mr. Stowers' conversation, but noted that he was acting strange and was wanting a massage. Mr. Manthe told me he remembered that Mr. Stowers was only in the massage room for approximately five minutes before he left.

I then made contact with Mr. Stowers again, trying to get further information as to his address, at which time he refused. I then asked Mr. Stowers if his friend was willing to give a statement as to what had occurred, at which time he told me that he was in the process of getting married and has a fiancee and would not come forward.

Mr. Stowers did tell me he was doing this on his own accord and his friend did not have any knowledge of him doing this. Mr. Stowers stated that this kind of action is not right and he feels that something should be done about it.

It should also be noted while talking to Mr. Manthe, he did tell me that the Camelot Massage Parlor was going to shut down in approximately a month as the
