On 05/06/2011, at 1316 hours, I was dispatched to 1125 Vandiver Drive, in reference to a trespass subject.

Upon arrival, I made contact with the complainant, identified as Ronald Clark. Clark advised his friend had brought over a woman and he had advised her to leave, but she wouldn't. Upon making contact with the woman, later

identified as Jessica Nole, she seemed very disoriented and didn't quite know where she was. I asked Nole what had been going on to which she advised needles were in the blanket that was near and she had been stabbed with multiple needles during the course of the night.

Nole advised she had been awake for nearly three days due to ingesting methamphetamine. Nole also advised she had finally gotten some sleep, but just woke up as myself and Officer Julie Marty had entered the residence.

Upon removing Nole from the residence, Nole advised she was a prostitute and the house she was staying in was facility of prostitution.

Nole advised she had done drugs regularly, and the last time she had done them was three days ago, and when she was coming down from her high at the current moment. I asked Nole how many men she had slept with in the past three days, to which she advised approximately 10 and she had once again stated she had been awake for three days.

When the Jefferson County Sheriffs Department recontacted Officer Timmerman, he was advised they would extradite her back to Jefferson County

After being advised of this by Officer Timmerman, Nole was placed under arrest until Jefferson County Sheriff's Department could relocate to Columbia.

Nole was placed in Interview Room III of the Columbia Police Department at 1500 hours to which she stayed under the supervision of myself and Officer Julie Marty until approximately 1846 hours, when Jefferson County Sheriff's Department arrived. After a search of Nole, the Jefferson County Sheriff's Department Deputies placed her in their custody and began to transport her back to Jefferson County without further incident.

I'm attaching a copy of the Order from the Judge stating she is wanted for a Probate Warrant to this report.
