On 06/07/2011 at approximately 8:20 p.m., I went to 1125 Vandiver in reference to an attempting to locate a Rainna Kay Bailey. I believed Bailey to be at the residence and I knew she had a parole absconder warrant with no bond.

I went to the location and made contact with a male individual, identified as Berry Manthy. I asked Manthy if Rainna Bailey was there and he pointed into

the other room. I went into the back area and located two females and I asked one female what her name was and she stated Rainna Bailey. At that time, I asked Officer Papineau to handcuff her that I believed that she was on a parole absconder warrant. It should be noted that Officer Papineau and Officer Hibler assisted me on this call.

I ran Bailey through Joint Communications and they advised she had an active probation and parole absconder warrant out of Jefferson City.

Bailey was transported to the Columbia Police Department where she was processed and later taken to the Boone County Jail by jail authorities.
