On 09/03/11 at approximately 2045 hours, I made telephone contact with Barry Manthe in reference to items being stolen from his residence at 1125 Vandiver Drive. Manthe stated he lives in a residence with two other roommates. He stated he left his residence just prior to 1500 hours and arrived home at 1700 hours. When he arrived home, his roommate, Ronald Clark, advised him Melissa Baker, a friend of Manthe's, came to the residence. Clark advised Manthe that Baker was there for approximately fifteen minutes. Clark stated she went into Manthe's room at which time he did not see her. Clark stated he observed Baker leaving in a white vehicle sitting in the rear seat. Clark advised David Sandoval, the boyfriend of Baker, was driving the vehicle. Clark told Manthe he and the other roommate did not observe Baker take the safe but believed it most likely was her.

Manthe stated the following items were missing:

1. Twenty-five Pound Silver Safe, valued at \$30.00;
2. Electronic Book Reader, valued at \$100.00;
3. Approximately \$600.00 in cash.

I asked Manthe if Baker knew about the safe. Manthe stated Baker knew he kept a large amount of cash in the safe. Manthe stated he has been good friends with Baker for a long time and believed she probably was responsible for taking the safe. Manthe stated he attempted to locate her at her residence at 1624 High Quest Circle but was not able to make contact with her. Manthe stated Baker did not have a phone so he could not contact her via phone.

Manthe had no further suspect information. I will attempt to located Baker to question her about this case/investigation.
