Warrant arrest at a local residence.

On 01-25-2012, at approximately 2336 hours, Officer Dollens and I responded to 1125 Vandiver Dr. We obtained information a female, identified as Melissa Baker, was possibly at the residence, and had an outstanding warrant.

Upon arrival we spoke with a male subject who identified himself as the resident. We asked to speak with Melissa and implied she was inside. HE went

back inside to look for her and returned a short time later. He gave me permission to enter and pointed towards a back room stating she went that way.

Baker was located inside the residence. I detained her in handcuffs. The warrant was confirmed active. I searched her person incident to arrest, no evidence was found. I transported Baker to the Columbia Police Department.

She was processed to include fingerprints and photographs. Her property was inventoried. Baker made several phone calls.

The warrant was issued out of Randolph County on 01-17-2012 for a probation violation on the original charge of Child neglect--non-support.

Baker was transported to Boone County Jail in lieu of \$5000 cash only bond.
