NARRATIVE

On 02/10/2012, at approximately 0145 hours, I was on the lot of Joe Machens Hyundai, 1300 Vandiver Drive, observing traffic in the area. I observed a tan 2002 Buick Century, bearing Wisconsin Registration 679PMN, traveling eastbound on Vandiver. I observed the Buick's license plate lamps were not functioning. I followed the Buick and conducted a traffic stop on Burlington near Vandiver.

I approached and made contact with the driver and identified him as Barry Manthe. I identified the front passenger as Melody Green. I advised Manthe of the reason for the stop and checked both subjects through MULES.

A check of Green through MULES revealed an active warrant for her arrest. I checked the warrant information with the Social Security Number Green had given and determined the warrant was active for Green.

Joint Communications confirmed the warrant and at 0158 hours, Green was taken into custody for the following warrant:

1. Warrant #12AAFTA1
2. Warrant Date: 01/12/2012
3. Charge: FTA Unlawful use of Drug Paraphernalia
4. Bond amount: \$500.00 cash only

I escorted Manthe to the rear of his vehicle and showed him the license plate light violation. Manthe consented to a search of the Buick. A search was conducted and no contraband was located. Manthe was released from scene with a warning for defective equipment. Green was transported to the Columbia Police Department for processing.
