On 06/19/14 detectives with the Columbia Police Dept Vice Narcotics Organized Crime unit and Street Crimes Unit with the assistance of the Federal Bureau of Investigation were conducting a prostitution operation at 915 Port Way (Holiday Inn).

During the operation, Charlotte HOLLINGSWORTH was taken into custody. Detective Giger read HOLLINGSWORTH her Miranda warning, and she advised she understood. Special Agent S. McDermott with the Federal Bureau of Investigation and I then conducted the interview of HOLLINGSWORTH.

During the interview HOLLINGSWORTH conveyed to McDERMOTT and I that she had been dropped off at the motel by a subject known to her as "Barry." It should be noted other officers had taken into custody Barry MANTHE in the parking lot area of 915 Port Way.

HOLLINGSWORTH advised she had agreed to pay MANTHE \$50 for the transportation to the motel. HOLLINGSWORTH advised this was a standing arrangement she had with MANTHE.

During the interview HOLLINGSWORTH admitted to agreeing to accept payment of \$200 in exchange for sex.

At the conclusion of the interview HOLLINGSWORTH was escorted to the parking lot area where I released her to the custody of Officer Terranova who had arrived to assist with transport.
