On 06/19/2014 members of the Vice Narcotics Organized Crime Unit, Street Crimes Unit, and FBI conducted an undercover prostitution operation at Holiday Inn, 915 Port Way. The goals of the operation were to attempt to contact prostitutes posting ads online, identify possible victims of human trafficking, and investigate any subjects involved in the promoting of prostitution.

On this date, all officers involved met at the Columbia Police Department for a briefing which was lead by Sergeant Harlan Hatton. Specific duties were handed out to each officer involved. My role in this investigation was to act in an

undercover capacity attempting to solicit prostitutes. We had rented a room at the Holiday Inn. I was in Room 435 while arresting officers and backup officers were in an adjacent room.

Sgt. Hatton had been contacting subjects with ads placed on backpage earlier in the week. Sgt. Hatton advised he had contacted "Cherrie" at phone #573-529-0126 by text message and had arranged to meet her on 6/29/14 and to purchase 1/2 hour of "full service" for \$200. "Full service" is a commonly used term to refer to sex in regards to escort services. All copies of the text messages will be placed into evidence along with a printout of the backpage ad. The ad has a picture of a white female in lingerie and states "couples and fetishes welcome".

At 1831 hours a subject later identified as Charlotte Hollingsworth arrived at the hotel room. I asked Hollingsworth if she was Cherrie and she said yes. I made small talk with Hollingsworth and asked her if the \$200 covered everything. Hollingsworth advised me that Greek was \$100 more and that "Girlfriend" was \$50 more. Hollingsworth explained that "Girlfriend" included cuddling and kissing. Greek is a commonly used term for anal sex in the prostitution culture.

Hollingsworth stated that to make sure I was not a cop I needed to touch her breasts. To maintain my undercover identity as well as for this investigation, I did briefly placed my hands on her breasts, however, it was outside of her shirt. Hollingsworth was wearing a dress as well as a lace bodysuit underneath. I observed Hollingsworth had a condom in her bra area.

I agreed to pay \$100 more for Greek and asked her if she wanted me to give her the money or set it on the counter. Hollingsworth told me to set it on the counter and I placed the \$300 on the counter.

Officers entered the room and placed Hollingsworth under arrest. Hollingsworth was mirandized and interviewed. See supplemental reports for further on the interview. It should be noted the room was equipped with video and audio recording capabilities. Copies of the video and audio will later be placed into Evidence at the Columbia Police Department.

After the interview it was determined that Hollingsworth had been driven to the hotel by Barry Manthe, and that Manthe was waiting for her in the parking lot. I have received information in the past that Manthe is involved in the promotion of prostitution. Manthe was located by officers and arrested.
