On 02/03/17, I received information from Detective Jon Voss that James Webb was believed to be at the Copper Beach apartment complex. Webbs address

is listed as 2299 Grindstone Parkway in the Columbia Police Department records system. We were aware on 02/02/17, a warrant was issued for Webb in reference to this case.

Detectives Kyle Gilliam, Ryan Terranova and I responded to the address in an attempt to locate Webb. We parked our patrol vehicles on the parking lot, down from the target address. As we approached the address on foot, we observed Webb and a female exit the residence. We made contact with Webb and he was placed into handcuffs without incident. I confiscated the black LG cellphone which was in Webb's hand at the time of his arrest. Webb was searched and nothing of evidentiary value was located on his person. The female was identified as Sydney Akers. Akers was driving a dark gray Chevy Trailblazer bearing Missouri registration WL7-N3A. Webb was advised that the residence may not be locked and he advised to leave the residence unlocked.

I transported Webb to the Columbia Police Department (CPD) for further investigation. Upon arrival at CPD, Webb was placed into a recorded interview room in order to speak with Detectives about this case. After speaking with Webb, I transported Webb to the Boone County Jail for processing.

While in route to the Boone County Jail, Webb and I were engaged in casual conversation. While speaking with Webb, he was asking for assistance with his case. I indicated to Webb that since there was a victim in his case, getting assistance would be difficult. Webb said, "the victim is a prostitute, I know it is". Webb asked if the victim is a female and I told him that I couldn't tell him. Webb said if the victim is a female, then she is a prostitute who is trying to get back at him. Webb said he could "take down the whole Vandiver house" if we wanted him to. As we were traveling north on Range Line near Vandiver, Webb looked to the east and he said that was the house. Webb also indicated that was where the victim is associated to. Webb said 1125 Vandiver was the "Ho House". Webb said he knew at least "four Ho's in there".

Upon arrival at the Boone County Jail, Webb was processed by taking his fingerprints for the following warrant:

Felony State warrant (# 17BAARW45) which was issued out of SO Boone County-Columbia on 02/02/17. The warrant had an original charge of 3 counts of Robbery 1st and 1 count of Assault 1st degree with a \$500,000 cash only bond.

After processing, Webb was transported to the Boone County Jail and he was released into their custody to await bond.


This incident was captured on my body worn and patrol vehicle cameras. The video footage will be retained as evidence for this case. The LG cellphone


