On 2/3/2017, I put together a photo array of a suspect in a robbery involving the victim, Tana Roland. Ms. Roland had been located at 1125 Vandiver Drive when she was forced to lie on the ground and she was subsequently shot by suspect, James Webb. Ms. Roland had identified another subject that was with Mr. Webb during the robbery and his name was Kaulic Williams, black male, dob: 2/19/97.

Detective Voss and I contacted the Missouri Information Analysis Center and requested them to complete a photo lineup for us. The photo lineup that they sent us via email was:

2. Kaulic Williams, 2/19/97, Social Security Number 515-13-6989
3. Wayne Bush, 6/10/92, Social Security Number 497-06-6643
4. Jerome Barnes, 6/17/95, Social Security Number 493-11-8985
5. Matthew Price, 10/12/92, Social Security Number 499-06-9392
6. Dedrick Cromartie, 11/5/95, Social Security Number 498-11-2125

Detective Voss and I traveled to 1125 Vandiver Drive to make contact with Ms. Roland. Once at the address, we came in contact with Ms. Roland. I informed her I had a photo lineup of six individuals I would like for her to look at. I informed her that the subject she had identified as being at the robbery may or may not be in the photo array. I asked her to just pick the person who she remembers being at the incident that occurred on 1/27/2017 when she was shot. Ms. Roland advised she understood the instructions and would attempt to pick out the subject.

The photo array was on one page of paper. Ms. Roland advised that the person she saw at 1125 Vandiver on 1/27/2017 was not in the photo array. I then asked Ms. Roland to initial the back of the photo array and date it, which she did.
