On 01-30-2017 beginning at approximately 1311 hours Detective Randy Nichols and I interviewed Barry Manthe at the Columbia Police Department. Manthe is a resident of 1125 Vandiver Drive where the robbery occurred. Manthe had given a statement to patrol officers the night of the robbery, but said he had additional information for the investigation. Our interview of Manthe was recorded, and a CD copy entered into Evidence. What follows is a summary, for complete details see the recording.

Manthe said the people in his house that night have since figured out who the suspect who did the shooting was. Manthe still maintained that he was in the back room during the robbery and did not see the suspects himself.

Manthe said he was told by Allen King that Tana Roland (the shooting victim) recognized one of the suspects from a picture that Lynda Young had. Manthe then explained in more detail how the situation came about. Manthe said he was contacted by Officer Chad Reynolds a couple of months ago "looking for the Mad Dog Kidnapper". After a few weeks Manthe was able to get a phone number to give to Officer Reynolds. Two weeks after that, Manthe said, James Webb came and took \$95 from Lynda Young. Manthe went on to say that Lynda Young was upset about this, and told him (Manthe) about a forgery operation Webb was running from his apartment.

Continuing, Manthe said he contacted Officer Reynolds and told him that Young wanted to give information on Webb's criminal operation. Young's information eventually led to Webb's arrest and incarceration.

Manthe said Lynda Young had been living in his (Mathe's) house for about a month, but she moved out the day Webb got out of jail (known to be 01-21-2017). manthe went on to say Young did not say why she moved out, but he added that she had been getting threatening messages from Webb about how he was going to come to the house and "get her". Manthe said Webb did not know Young had moved out of the house and was not at the house at the time of the robbery, and that during the robbery the suspects were asking "Where's that bitch?".



The day after the robbery, Manthe said, Allen King told him he recognized a picture of "the shooter" from Lynda Young's cell phone. Manthe said King told him the person in the picture was a guy named "Little legs". Manthe then said James Webb was in the picture with Little Legs. Manthe said he did not know when King saw the picture, and added that he did not think Young had been to his (Manthe's) house since the robbery.

I asked Manthe if any of the people at his house would know who James Webb is. Manthe said Rebecca Bushman would know Webb (Buschman said in her interview she did not know the one suspect she saw), but he did not know if Tana Roland knows Webb. Manthe also said he does not know Webb, and has never seen him.
