On 2/2/2017, Detective Voss and I traveled to 1125 Vandiver Drive to make contact with a witness/victim in this case. The person was identified as Allen King, Jr. Mr. King potentially had information in reference to the incident of a robbery/shooting at 1125 Vandiver on certain actions that he was forced to take during the robbery. King advised that he was located in a bathroom of the residence at 1125 Vandiver Drive. Mr. King stated that as he exited the bathroom, he came in contact with one of the male suspects. Mr. King stated he had heard voices from males when he was in the bathroom, yelling about getting on the ground, "this is a robbery" and "where the fat man at"? Mr. King stated that once he got out of the bathroom that he was forced to lie on the floor next to "Little Bit", also known as Tina Roland. Mr. King stated that he heard some banging and a gun shot towards the back of the living room. Mr. King stated that the male subject with the gun came back to where he (King) was lying on the floor. King said the male suspect states "that if someone does not open this door, there is going to be some shooting going on in this house".


Mr. King stated that he was then made to get up and break the window out of the doorway to the back part of the residence and was then forced to go back and lay down on the floor. King said that after the male suspect went to the back of the residence he then came back to the front where everyone was lying on the floor. Mr. King stated he did not see Ms. Roland get shot, but he did hear the shooting.

I also made contact with Ron Clark. Clark is considered a doorman/security at 1125 Vandiver Drive. Clark stated that he heard knocking at the door, went out to the door, and saw a subject there and then went to Tanas room and knocked on her door and told her someone was at the door for her. Mr. Clark was asked why he believed the subjects at the door were there for Ms. Roland when he had not made any contact with them? Clark stated that he did not see them but he believed they were there for Ms. Roland because she was the only one "working" at that time. Mr. Clark stated he made contact with Barry (Manthe) and told him to call 911 because he had overheard people yelling and shouting about a robbery.

These interviews were recorded by my digital recorder and will be placed onto a compact disk and placed into evidence.

The narrative to this report is paraphrased, for the full rendition of what was said please listen to the recording.
