

On 02-03-2017 I obtained a Court Order for real time precision location ("ping") of suspect James Webb's cell phone (312-887-2855), in addition to historical call detail records with cell site for the period of 01/21/2017 to 03/21/2017 (a future date, if needed). The beginning date of 01/21/2017 is the date Webb was released from the Boone County Jail - Webb is reported to have contacted Lynda Young with threats upon his release. The order was addressed to AT&T, and I served the order by fax at approximately 1020 hours.

Detective Randy Nichols and I determined that a danger existed to Lynda Young that necessitated a ping on Webb's phone to locate him. Our investigation had revealed that the motive for the robbery and shooting was retaliation against Young for giving police information on Webb in a separate case, for which Webb was arrested. Minutes after a warrant was obtained for Webb's arrest for the robbery and shooting, local news media (KMIZ) published a story on the warrant that included specific details apparently obtained from the Probable Cause Statement.

Once the pings of Webb's phone began, they showed him to be in Copper Beach off of Grindstone Pkwy. I relayed the ping information to Street Crimes Detective Tommy Quintana, who was able to locate and arrest Webb on the warrant obtained in this case.
