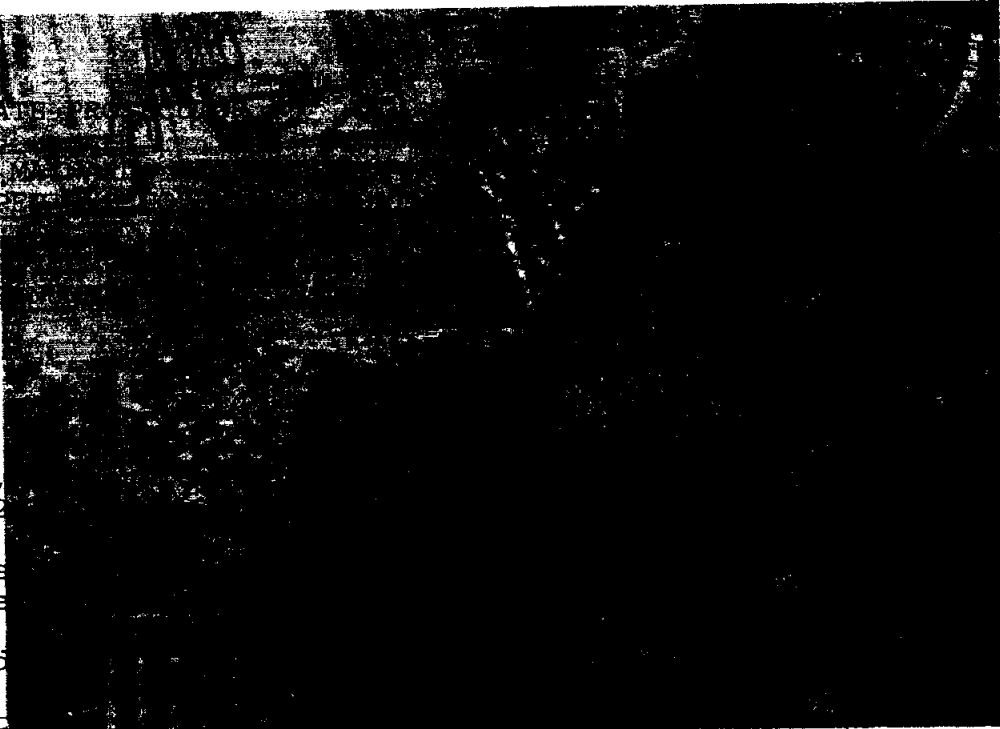

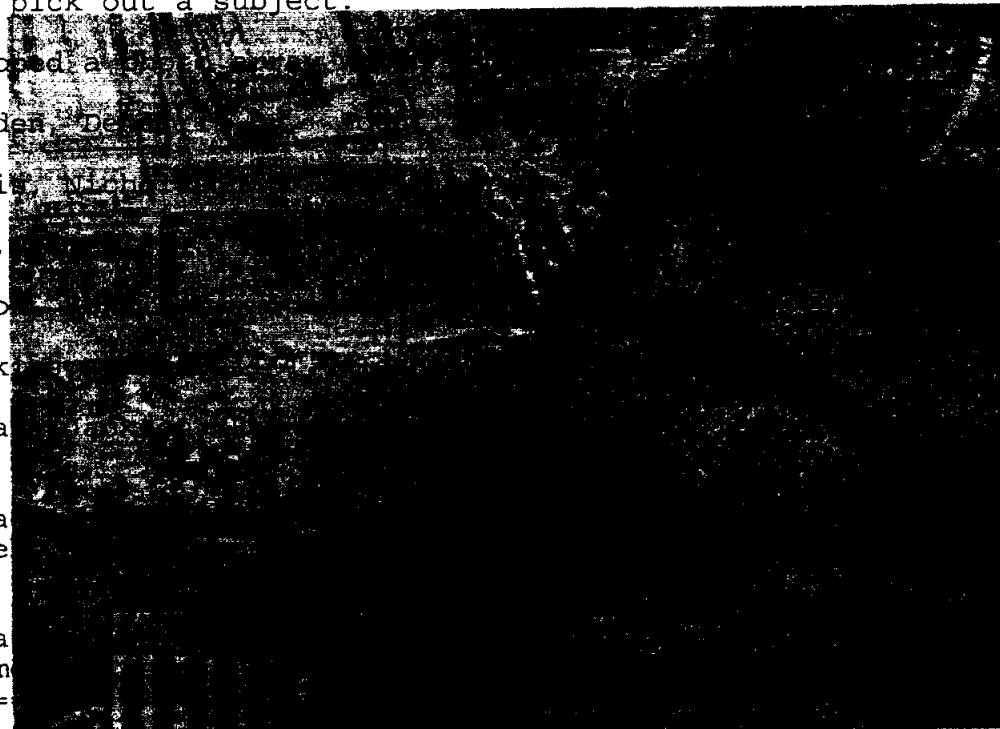



I explained that was why we were there and explained the process of picking a person out who she believed was the one who came into her room and I explained to her that I did not want her to identify this person from a picture she may have seen from somebody else showing it to her, I wanted the person who was in the room the night in question. I did not want her to guess, I just wanted her to be accurate and to tell me if the person was not in the photo array. I showed the photos one at a time starting with one and ending with six. When Buschman got to number three she said that she knew that individual but he was not the person who was in her room, number 3 was James Webb. It should be explained that as Buschman got to a photo she would put it aside and turn it over. As she turned over one, two, and three, when she got to four, she stated that was the subject who had been in her room with a gun. This subject was identified as Ronald Wilson, ID number of 366430. Buschman left that photo face up and then continued on looking at the photos and turned over photo five and photo six saying she did not recognize them. Buschman was asked where she remembered seeing number four, Ronald Wilson. She advised from the night he broke into her room. Buschman was asked to initial the photo and to date it, which she did. That was the end of our conversation with Buschman and we then left the residence.

The one sheet of photos of all six individuals plus the photos of all six individuals of the photo array will be placed into evidence.
