From the floor between the bathtub and East wall, in the Northwest bathroom, I collected, for evidence, one bag with a green leafy substance. When I arrived back at the Columbia Police Department I tested the green leafy substance, it tested positive for marijuana, and weighed approximately 18.31 grams.

From the North #1 bedroom I collected, for evidence:

1. One black Alcatel phone, from the bed;
2. One white LG Sprint slide phone, serial number 302CYAN0859614, from the purse near the West wall;
3. One salmon BLU phone, model StudioX, IMEI 358681060867327, found on the floor West of the bed;
4. One black RCA tablet, serial number GBFDCZ1094D4, found on the bed;
5. One used, capped, syringe found on the bed;
6. One spoon with residue, found on the black stand near North wall window;
7. One metal grinder, and two narcotic smoking devices, all found on the floor South of the bed;
8. One glass narcotic smoking device, found on the South wall shelf by the East wall door;
9. One plastic baggie with a small amount of a white powder substance, found on the floor, South of the bed.

When I arrived back at the CPD I tested the small amount of white powder from the baggie, found on the North #1 bedroom floor, South of the bed, it tested positive for methamphetamine.

From the bed of the North #2 bedroom I collected, for evidence, one gray/black LG AT&T flip phone, with serial number 013501004124097.

From the plastic storage container on the North wall in the Northeast bedroom I collected, for evidence:

1. One black 8GB Apple Iphone;
2. One black Motorola phone, IMEI 359486041758358;
3. One white Apple Iphone 5C, IMEI 358816050970323;
4. One white "hTc my" slide phone, IMEI 351810040504364;
5. One black/gray LG broken cell phone;
6. One black Samsung Galaxy S;
7. One black/blue LG phone, IMEI 014279-00-780526-4;
8. One blue Galaxy S4 with case, IMEI 359440050243158.

From the Northeast bedroom I also collected, for evidence, one black/silver Apple Ipad, serial number F7TLQCKEFP84, found between the bed and East wall.

From the Southwest bedroom I collected, for evidence:

1. One loaded and capped syringe, from the North wall closet;
2. Seven unused capped syringes, and two syringe bags, found on the bed;
3. Two syringe caps, and one used uncapped syringe, found in the North wall closet;
4. Four baggies with residue, and one spoon with residue, found in the North wall closet.

When I arrived back at the CPD I tested the residue in a baggie from the North wall closet, in the Southwest bedroom, and it tested positive for heroin.

From the West wall makeup table in the Southeast living room I collected, for evidence:

1. One glass narcotic smoking device;
2. One black WD external hard drive, serial number WCAU47388951.


When we were finished processing the residence I took exit photographs. I photographed the search warrant and search inventory list that I left on the kitchen counter. I didn't lock and secure the residence because there were residents present.

Items collected were transported, by Mitchell II and I, to the CPD to be packaged and placed into Evidence. Photographs taken were burned to a DVD and placed into Evidence. A routing form and lab request form were completed.

This case should be assigned to the criminal investigative division of the Columbia Police Department.
