On 01/27/2017, I was contacted by Lieutenant Barb Buck in reference a robbery that occurred and a person had also been shot and to also help assist in the interview of suspects and victims of this robbery. During the course of the investigation I came in contact with Tana "Little Bit" Roland. Roland had been shot by one of the suspects in this robbery. I questioned her on 1/28/2017 and she gave me information that she had given officers that night about what had occurred.

On 01/30/2017, I was contacted by Sergeant Maynard asking me to contact a Barry Manthe. Manthe is the renter of 1125 Vandiver Drive. Manthe stated he had information about possible suspects in reference to this incident and that he wanted to come to the Columbia Police Department and contact me about that. We made arrangements for Manthe to come to the Columbia Police Department for the afternoon of 01/30/2017.

Manthe arrived at the Columbia Police Department and with him was the victim of the shooting/robbery, Tana Roland. Roland advised me she believed she could identify who had shot her and also identify the other male that was with the shooter.

Detective Jon Voss assisted me with this interview and we started interviewing Roland at approximately 1:43 PM. I escorted Roland to Interview

Room #2. Once there, the interview was recorded with both audio and video and also by my digital recorder. The recordings from all devices used were placed onto two compact disc(s) and later placed into evidence.

I inquired with Roland about what she was doing during the evening of 01/27/2017. Roland advised me that she sometimes stays at 1125 Vandiver Drive. Roland said that she is friends with Barry Manthe and some of the other individuals that frequent that address. Roland advised that she had been in Columbia on that day from St. Louis and she had gone out prior to staying at the residence for several hours. Roland advised she came back to 1125 Vandiver Drive at around 7:30 PM and had plans to go out with a friend and go to a restaurant, however, there was a vehicle issue and they were not able to leave the residence.

Roland advised she was in her room when there was a knock on her door. Roland stated she believed either "Ron" or one of the girls had knocked on her door and said there was somebody at the other door which she took to mean the front door entry way. Ron is the door man/security for 1125 Vandiver Drive. Ron's given name is Ronald Clark. Roland advised she was expecting her cousin but she was not told who the subject was at the door other than there was somebody knocking at the door. Roland was also not certain who knocked on her room door and gave her that information.

Roland said she walked to the front door, looked out the door and there was a black male up against the door who she said she did not recognize and there was a male standing behind him who she knew as "Little Legs". The entry way door is a glass sliding door. Roland said the male that was at the front door was too close to it, so she could not identify him at that time.

Roland said she was expecting her cousin and this gentleman somewhat resembled him so she opened the door for him. When she opened the door the subject had a pistol and told her it was a robbery and for her to get back. Roland said she was made to lay on the floor and also her man "Allen" was eventually made to lay on the floor in the living room. Roland stated the black male subject with the firearm was asking where the "fat man" was and "where the bitch was at". Roland stated the subject kept repeating those two questions. Roland also advised she somewhat recognized the individual as he walked away from the door where the light was making it a problem for her. Roland stated that the guy with the gun appeared to be the one in charge and he was pointing the gun, yelling at people and asking for the "fat man" and the "bitch". Roland stated the other male subject did not say anything and stood there with his hands in his pockets. Roland stated that she knew "Little Legs" as Kaulic Williams and she had seen him prior to this incident.

Roland advised the other subject with the gun went to the back of the room and she could hear him beating on the door. Roland stated that eventually the male came back and made her friend "Allen" go back to the back of the room and break out the window of the doorway so that the male could unlock the door. Roland said she heard one shot as they went back to the back door and then heard shouting and someone said somebody had called the police and the black male came running from the back and as he passed her he pointed his gun at her and shot her. Roland was positive the male with the gun looked directly at her and shot her. Roland said she was struck in the stomach. Roland said she did not know why she was shot, because she had been doing everything that was asked of her.

Roland stated during the yelling the male with the gun said they "had come all the way from Chicago and heard about you all" and he kept asking about the fat guy and asking where the bitch was at. Roland stated at that time while she was lying there she was trying to put the pieces together and believes she remembered the guy with the gun as being with "Monica" also known as Lynda Young. Roland advised she knew these two were connected because "Monica" had gotten the gentleman with the gun arrested. Roland stated she wasn't for certain on that night of the incident that this was the subject whose name she knew, she only knew him as "Jambo", but later found out his real name was James Webb.

Roland advised after the subjects left she stood up and started walking and knew she had been shot because she could see the blood and people started scrambling around and police arrived shortly after 911 was called. Roland stated the next day, which was 01/28/2017, which was Saturday, "Monica", otherwise known as Lynda Young came to 1125 Vandiver. While she (Monica) was there they were talking about what had occurred the previous night. Roland was telling "Monica" that she needed to tell her (Roland) what was going on because she got shot because of something "Monica" had done. During that conversation "Monica" showed several people at the residence a picture of "Jambo" and "Little Legs" that was on her cellular phone.

Roland advised Detective Voss and I that "Monica" had been receiving phone calls and threats from "Jambo" because he had been arrested because of "Monica" turning him into the police. Roland told Detective Voss and I that at some point Webb had called the house phone at 1125 Vandiver asking for "Monica" prior to the shooting incident occurring, but shortly after he had gotten out of jail. Roland advised "Monica" was very scared and was worried about her safety because they all agreed that Webb had come to the residence with harmful intentions for "Monica".

Roland stated after she looked at the picture of Webb on "Monica's" cellular phone she knew that he had been the one that shot her on 01/27/2017.

Roland was asked how many times total she had seen both "Little Legs" and Webb prior to this incident. Roland stated she had seen each subject once prior to the incident on 1/27/17. Roland said that she had seen "Little Legs" around Thanksgiving because he had been with "Monica" at 1125 Vandiver. Roland said she had seen Webb at least one other time and it was within the last month or month and a half and he had conversation about her needing a ride in reference to what she does for work at 1125 Vandiver.

Roland was asked if she could identify the subjects with the knowledge of what had occurred on Friday night or if she only knew them from only having seen them once. Roland said she was positive she could identify both subjects if she was able to view a photo lineup. Roland also stated she had seen "Little Legs" on Facebook and he used his real name on Facebook.

Detective Voss and I left Roland in the interview room and retrieved a photo lineup for Roland to view. Roland had said she could pick out Webb from the photo lineup. The photo lineup consisted of the following individuals:

The photos of these individuals were done as single photos one through six. These photos were showed to Roland in sequential order one through six. Roland chose photo number 4, James Fernando Webb.

Prior to viewing these photos, Roland was instructed that the person that she believed had shot her may or may not be in the photo array. Roland was also instructed that we did not want her to pick a photo based on who she saw prior to the incident at 1125 Vandiver. Roland was asked to choose who shot her and committed the robbery that night. Roland advised she understood the

instructions she was given and she informed us she would do that. Roland selected James Webb from the photo array. Roland was asked where she had seen Webb. Roland advised that Webb was the person who shot her and committed the robbery at 1125 Vandiver.


Also during the interview of Roland, she signed a medical release form which will be given to the prosecutor's office. The evidence reference this supplement will be the photo array and the audio/video placed onto a compact disc and the recording from my digital recorder which will be placed on a disc.

Based on Roland picking Webb from the photo array, a warrant request will be submitted for the arrest of James Fernando Webb.

The narrative to this is paraphrased and for all of what was said please refer to the recordings that were made.
