SUMMARY: THIS INCIDENT CONSISTED OF A VEHICLE PURSUIT AFTER THE VEHICLE LEFT A SHOOTING IN THE CITY OF COLUMBIA.

ON 01-27-2017 AT ABOUT 2312 HOURS, I, DEPUTY PATRICK RICHARDSON OVERHEARD DISPATCH PROVIDE INFORMATION REGARDING A BURGLARY/SHOOTING AT 1125 VANDIVER DRIVE. DISPATCH STATED SEVERAL BLACK MALES ENTERED A RESIDENCE WITH FIREARMS AND A FEW MINUTES LATER, SHOTS WERE FIRED. A FEW SECONDS LATER, DISPATCH ADVISED THAT ONE SUBJECT WAS SHOT INSIDE THE RESIDENCE.

DURING THE TIME OF DISPATCH, I WAS ON OAKLAND GRAVEL ROAD NEAR VANDIVER DRIVE. I TURNED WESTBOUND AND TRAVELED TOWARD THE INCIDENT TO PROVIDE ASSISTANCE TO COLUMBIA POLICE OFFICERS.

WHILE TRAVELING WESTBOUND ON VANDIVER DRIVE, I TURNED OFF MY EMERGENCY EQUIPMENT AS THE SUSPECTS WERE LIKELY (BASED ON MY EXPERIENCE) LEAVING THE AREA DURING THE TIME OF DISPATCH. I FELT MY BEST OPPORTUNITY TO LOCATE THE SUSPECTS WAS TO DRIVE NORMALLY TOWARD THE LOCATION OF THE SHOOTING AND OBSERVE ALL TRAFFIC LEAVING THE AREA.

I PASSED PARKER STREET AND NOTICED A TAN CHEVROLET SUV BEARING MISSOURI REGISTRATION PP4H3K TRAVELING TOWARD ME, EASTBOUND ON VANDIVER DRIVE. THE DRIVER WAS NOT MAINTAINING THE LANE AND THE VEHICLE WAS CLEARLY EXCEEDING THE POSTED SPEED LIMIT.

I TURNED MY VEHICLE AROUND AND NOTICED THE VEHICLE TURNED NORTHBOUND

ON PARKER STREET FROM VANDIVER DRIVE. THE VEHICLE WAS TRAVELING AT AN EXCESSIVE SPEED AS IT WAS OBVIOUS THEY WERE TRYING TO EVADE LAW ENFORCEMENT. I NOTIFIED DISPATCH AND INITIATED A VEHICLE PURSUIT.

THE VEHICLE TURNED EASTBOUND ONTO HOLLY AVENUE AND ALMOST IMMEDIATELY CAME TO A STOP ON THE SIDE OF THE ROADWAY. I THEN SAW TWO BLACK MALES EXIT THE PASSENGER SIDE OF THE VEHICLE AND RUN SOUTHEAST BEHIND A RESIDENCE. I DROVE MY PATROL VEHICLE THROUGH THE GRASS IN AN ATTEMPT TO GAIN LOST SPACE ON THE SUSPECTS. I THEN EXITED MY PATROL VEHICLE AND PURSUED THE SUSPECTS ON FOOT. I NOTICED A SUSPECT WEARING A BULGY, BLACK JACKET WAS CARRYING A HANDGUN IN HIS RIGHT HAND.

I CONTINUED TO PURSUE THE SUSPECTS AS THEY BEGAN RUNNING EASTBOUND INTO THE WOODS. I FOLLOWED THE SUSPECTS INTO THE WOODS FOR APPROXIMATELY 10 YARDS UNTIL THE SUSPECTS SPLIT UP. I THEN PAUSED FOR A MOMENT AND MADE THE DECISION TO NOT FOLLOW THE SUSPECTS BY MYSELF AS AT LEAST ONE OF THEM WERE ARMED.

I BACKED OUT OF THE WOODS AND AWAITED CANINE. WE TRACKED THE SUSPECTS EASTBOUND ON THE SOUTH SIDE OF HOLLY AVENUE UNTIL CANINE LOST SCENT NEAR NORBURY DRIVE.

I RETURNED TO THE SUV AND LEARNED THE DRIVER WAS TAKEN INTO CUSTODY. THE DRIVER WAS IDENTIFIED AS ANTHONY HAYES. I SPOKE TO ANTHONY AFTER HE WAS READ HIS MIRANDA RIGHTS. ANTHONY WOULD NOT ANSWER MY QUESTIONS DIRECTLY AND STATED HE DID NOT KNOW THE SUBJECTS THAT RAN. ANTHONY SAID HE WAS NEAR A TRAILER COURT ON RANGE LINE STREET WHEN THE SUV PULLED UP BESIDE HIM. ANTHONY STATED THE DRIVER WHO HE KNEW ONLY AS JEREMY ASKED HIM TO DRIVE. ANTHONY DENIED STOPPING ANYWHERE ON VANDIVER DRIVE.

SERGEANT JEFFREY FORCK STATED HE WOULD LIKE ANTHONY TRANSPORTED TO THE COLUMBIA POLICE DEPARTMENT FOR DETECTIVES IF I WOULD AGREE. I ALLOWED THIS TO OCCUR. I PROVIDED SERGEANT FORCK WITH THE INFORMATION REGARDING MY PURSUIT AND HE STATED THE DETECTIVES WOULD BE CALLING ME LATER. I ALSO RELINQUISHED THE VEHICLE TO THE COLUMBIA POLICE DEPARTMENT SINCE WITNESSES DESCRIBED THE VEHICLE AS THE SUSPECT VEHICLE IN THE SHOOTING.

IT SHOULD BE NOTED; CRACK COOKIES WERE SCATTERED ALL THROUGHOUT THE VEHICLE AND ON THE SIDEWALK NEAR THE PASSENGER DOORS. ALL EVIDENCE WAS TAKEN BY MEMBERS OF THE COLUMBIA POLICE DEPARTMENT.
